The Seller guarantees that upon receipt of the puppy it is in good health and has been immunized and wormed according to the health records provided herein. Every Beefy Blissful Bulldogs puppy is vet-checked, microchipped, up-to-date on vaccinations and deworming, and is accompanied by a one-year congenital health guarantee from the date of birth.

1. AKC REGISTRATION & PET QUALITY TERMS

1. Millie's litters are AKC registered. AKC-registered puppies sold to pet-quality homes are **required to be spayed or neutered** as a condition of this sale. Buyer agrees to spay or neuter the puppy by twelve (12) months of age and to provide written confirmation from a licensed veterinarian to Seller upon completion.
2. Gia's litters are sold as pet-quality homes only and are not AKC registered. Spay/neuter is strongly recommended for all of Gia's pet-quality puppies.
3. All puppies are sold as **pet quality**. Seller does not guarantee the puppy's ability to sire or whelp puppies, nor the adult color, size, or conformation.

2. DEPOSIT & PAYMENT TERMS

4. A non-refundable deposit of **\$1,000.00** is required to reserve your puppy. The deposit is applied toward the total purchase price.
5. **All deposits are non-refundable for any reason whatsoever.**

6. The puppy must be paid in full by eight (8) weeks of age. Failure to complete payment forfeits all deposits and all claims to the puppy, unless a written extension has been agreed in advance by both parties.

3. ONE-YEAR CONGENITAL HEALTH GUARANTEE

■ **ACTIVATION REQUIRED:** Buyer must have the puppy examined by a licensed veterinarian within seventy-two (72) hours of delivery or pickup and must notify Seller of the result immediately by phone or email. Failure to complete this step renders this guarantee null and void.

7. This puppy is guaranteed against fatal or life-altering congenital (genetic) defects for one (1) year from the date of birth. Covered conditions include serious defects of the kidney, heart, pancreas, spine, and liver that are severe, life-threatening, or life-altering in nature.
8. **All guarantee claims are fulfilled through a replacement puppy of equal value** from Seller's available or upcoming litters. **Seller does not offer cash refunds under any circumstances.**
9. To submit a guarantee claim, Buyer must: (a) notify Seller in writing within two (2) business days of the veterinarian's diagnosis; (b) provide a written report from the examining veterinarian; (c) provide a second confirming report from a second independent licensed veterinarian; and (d) authorize Seller's access to all veterinary records. Failure to satisfy any condition voids this guarantee.

10. Buyer must maintain the puppy under the continuous care of a licensed veterinarian, including all recommended vaccinations and routine care. Buyer must retain all veterinary records. Failure to do so voids this guarantee.

4. DELIVERY & FLIGHT NANNY

11. For puppies delivered via flight nanny, the seventy-two (72) hour veterinary examination window begins at the time of delivery to Buyer, not at departure from Seller's home.
12. The puppy is in the care of the flight nanny from the time it leaves Seller's home until delivered to Buyer. Seller is not responsible for illness, injury, or stress that may occur during transport beyond Seller's control.
13. Buyer is responsible for all flight nanny fees, transport costs, and applicable airline charges. All other guarantee terms apply identically to local pickups.

5. RETURNS & REPLACEMENTS

14. **A puppy with a covered defect must be returned to Seller in good condition — other than the specified defect — at Buyer's expense to qualify for a replacement puppy. If Buyer refuses to return the puppy at Seller's request, Buyer accepts full responsibility and this guarantee is null and void.**
15. If Buyer elects to keep a puppy with a covered condition rather than return it, Buyer forfeits all rights to a replacement puppy and Seller bears no responsibility for future veterinary expenses.
16. No puppy shall be euthanized without Seller's prior knowledge and consent, except in an emergency requiring immediate humane treatment. A signed veterinarian certificate, all health records, and an autopsy/lab report are required to claim a replacement following death.
17. Replacement puppies will be mutually agreed upon by both parties and will be of comparable quality. The replacement may not come from the exact same parents. Buyer is responsible for all transportation costs on a replacement puppy.
18. If Buyer is no longer able to care for the puppy at any time, Seller will accept the dog back and assist with placement to ensure it is not surrendered to a shelter or unwanted home.

6. CONDITIONS NOT COVERED BY THIS GUARANTEE

The following conditions are expressly excluded from this guarantee, including but not limited to:

- a) Cherry eye, entropion, loose hips, elongated soft palate, stenotic nares (collapsed nostrils)
- b) Skin allergies, food allergies, demodectic mange, autoimmune disorders, thyroid dysfunction
- c) Kennel cough (self-limiting; full recovery expected), coccidia, internal parasites, bacterial or viral infections
- d) Hypoglycemia, umbilical hernias, undescended testicles
- e) Joint problems of any kind — hips, knees, or other joints — arising at any time after delivery
- f) Parvovirus contracted after the 72-hour veterinary examination window
- g) Heat stroke — Buyer is responsible for providing a safe, climate-controlled environment
- h) Health issues resulting from overfeeding, improper diet, obesity, or inadequate care
- i) Hip dysplasia — all puppies are vet-checked and cleared before leaving; problems may arise from external factors beyond Seller's control
- j) Skin fold irritation, eye problems associated with wrinkles, or structural issues inherent to breed conformation

7. ADDITIONAL TERMS & CONDITIONS

19. All veterinary expenses are the sole responsibility of Buyer. Seller will not be responsible for any medical costs incurred at any time.
20. This guarantee is non-transferable and applies to the original Buyer only.

- 21. Buyer is strongly encouraged to purchase pet health insurance for their English Bulldog. Consult your veterinarian to select a policy appropriate for the breed.
- 22. This contract is null and void if any terms or conditions are not fulfilled by Buyer.
- 23. Any dispute or litigation concerning this contract that cannot be resolved by mutual agreement shall be settled under the jurisdiction of Montgomery County, Dayton, Ohio.

8. PHOTO & SOCIAL MEDIA CONSENT

24. By sharing photos or videos of your puppy with Seller, Buyer grants permission for Seller to use such content for promotional purposes on the website and social media platforms. Buyers who wish to opt out must notify Seller in writing at time of purchase.
